## INSURANCE – LICENCE

Riders who do not hold a licence are covered by their civil liability insurance when at the Centre when on foot and only within the framework of the facilities. The riders must take out a special individual riding insurance on arrival at the Centre before starting the activities: this insurance costs 25 Euros.

## GENERAL CONDITIONS

The enrolment to one of our courses or treks entails acceptance

- **PRICES ARE INCLUSIVE OF VAT** but do not include drinks except during the meals, possible visit costs, individual insurance, or a supplement for an individual bedroom.
- **INSCRIPTION** cannot be confirmed until the inscription form and a 30% deposit of the total charge are returned to us at least 21 days before the beginning of the course or trek, or 50% deposit of the total charge if the enrolment is made during the 21 days preceding the starting date of the course or trek.
- **Any CANCELLATION** on the part of the client between 21 and 10 days before the course or trek will entail a loss of 50% of the deposit and within 10 days of the course or trek, a loss of 100% of the deposit. If the Centre cancels the course or trek, in particular when there are fewer than 4 persons enrolled, the client will be informed at least 8 days before the beginning of the course or trek; a replacement option will be offered as far as it is possible. For the contrary, the full amount of all sums paid will be reimbursed and a 10% discount will be given for the next inscription. Withdrawal during a trek will give no entitlement to reimbursement.
- **REPONSIBILITIES**  
Each participant undertakes to respect all rules on caution and security linked to the activity. The organiser can not be held responsible if these rules are not respected. The guide has the right to expel a rider whose behaviour could jeopardise the safety and well-being of the group, without being owed any compensation.  
The programmes and itineraries published in our brochures are liable to be changed. So as to take advantage of the optimal access conditions to the beach, tide times must be taken into account.  
The guide reserves the right to change a programme of an itinerary if circumstances require it.
